 - (a) Social members who are under the age of eighteen and wish to become active upon turning eighteen may attend classes and/or drills during their social membership, with the approval of the Executive Board and the Chief.

- (D) Social members shall be non-active members who assist with fundraisers, building maintenance, and may provide canteen services for extended calls, as requested by PVFC line officers.
- (E) Social members may not participate with any firefighter duties, be provided gear, pagers, or key, and may not respond on an apparatus to an emergency scene.
 - (a) Social members may be provided with gear for class and/or drill purposes only, as approved by the Executive Board and the Chief.
- (F) Social members must attend a minimum of fifty percent of fundraisers and will be assessed on a six-month basis.
- (G) Social members may be dismissed at any time by the Executive Board without company approval.
