Junior Firefighter / Recruits applicants must provide a valid age certificate (16 & 17 year old) for PVFC to keep on file for any minor employed or associated with the department. The certificate is similar to a work permit, and *may be issued by the superintendent.*

All applicants are subject to an interview unless waived by the Executive Board.

Applicants must reside within ten road miles of the incorporated limits of the City of Petersburg.

- **Responsibilities:**

- May participate in training, provide first aid at a safe distance, and perform cleanup or canteen services outside structures.
- **Prohibited:** Operating fire equipment, driving fire vehicles or POVs with lights/sirens, entering burning structures.
- May only respond to a fire while school is in session or during school hours if the fire official in charge has obtained permission from the minor's school principal

- **Expectations:**

- Maintain a minimum GPA of 2.0, participate in at least 50% of fundraisers, work details, meetings, and drills.
- Limited to six Junior Firefighters at any time.
- Must adhere to lawful orders and are not permitted to respond to calls without prior line officer approval.
- Junior Firefighters are not permitted to be in a responding fire apparatus unit using lights and sirens for active calls, unless directed otherwise by the highest ranking line officer present.

I have thoroughly read this application, and it is completed with honest information. I understand that this is an application, and if accepted, I will abide by the by-laws of the Petersburg Volunteer Fire Company for membership.
